- used to contact me, where necessary, before, during or after the event,
- used to ensure the safe and orderly conduct of the event,
- used to respond to participants' requests and questions,
- used to carry out administrative and operational processes relating to the event

and that such data may be recorded, processed and retained by Telateks Tekstil Ürünleri San. ve Tic. A.Ş. for these purposes.

I have been informed that photographs and video recordings covering the general areas and activities of the event may be taken during the event and that my voice may be included in video recordings.

I acknowledge that the photographs, video recordings and audio recordings obtained within this scope may be recorded, processed and retained by Telateks Tekstil Ürünleri San. ve Tic. A.Ş. solely for the purposes of;

- documenting the event internally within the Company,
- preparing event reports,
- creating corporate activity records,
- creating the Company's internal archive relating to the event

and that such data may be recorded, processed and retained by Telateks Tekstil Ürünleri San. ve Tic. A.Ş. for these purposes.

I have been informed that, to the extent necessary and limited to the purposes specified in the Information Notice, my personal data may be shared with;

- authorized Company employees involved in organizing the event,
- suppliers providing organization and event services,
- suppliers providing name badge printing services,
- service providers responsible for the hotel and dinner organization where the event will take place,
- service providers that provide photography, video recording or technical processing services on behalf of the Company and are subject to confidentiality obligations,
- public institutions and organizations legally authorized for the purpose of fulfilling legal obligations

within the scope described above.

I acknowledge that my photographs, video recordings and audio recordings will not, unless my separate explicit consent is obtained;

- be published on the social media accounts of the Company or METYX,
- be published on websites,
- be used in printed promotional materials,
- be used in advertising, marketing or promotional activities,
- be published through other public communication channels

and will not be transferred abroad.

I acknowledge that I may withdraw at any time the explicit consent I have given for the processing of my personal data for the purposes stated above by applying to Telateks Tekstil Ürünleri San. ve Tic. A.Ş., and that the withdrawal of my explicit consent will take effect prospectively from the date my request reaches the Company.
